Sierra cars have a self-insulator to put out fires, **Safety protocol:** Each vehicle entered needs the following- A high voltage fire blanket (vehicle sized), 2 safety crew members, High voltage gloves, and a rubber hook.

Race Directors should reach out to fire depts local to the races to see if they are equipped to handle an electric vehicle fire.
